Letter from the place of work (In Original) containing following details: Name, Passport No., Purpose of travel, duration of stay and signed by the authorized signatory with contact details and company Email id and website. E. Invitation Letter/ Contract in Hebrew/ English containing following details:Name, Passport No., Purpose of travel, duration of stay and signed by theauthorized signatory with contact details and company Email id and website. F. Copy of Aadhaar card/Election card/Pan card and Current valid Passport (1st & Last Page).

- **3.** Embassy may ask for Additional Documents.
- **4.** If married, then Passport should be updated with the spouse name as well as the spouse passport also to be updated with the spouse name along with submit Original Marriage Certificate with Apostille with updated spouse name.

5. IN CASE OF MINOR ACCOMPANYING PARENTS: -

- a) Need original Birth Certificate with Apostille (attested by MEA).
- b) Parents (Father & Mother) need to visit IVP at the time of submission for signing the Minor consent form (Only for Delhi) and For Mumbai and Bengaluru (Parents (Father & Mother) need to visit consulate office for signing the Minor consent form upon appointment).
- c) In case one of the parent is not in India then he/she must sign the Minorconsent form at Embassy of Israel in that particular country.
- d) The Institute/Company/ Business in Israel must arrange the approval from Ministry of Interiors of Israel.
